Conditions and Guarantee of Stud Service

1. The Female Dog must be in good Health, current on all shots also a Veterinary health examination with a current Brucellosis test must be provided before breeding will take place.
2. The Female Dog Owner must provide a copy of her pedigree and registration certificate (front and back) showing that they are the owner(s) of the Female Dog.
3. The Stud fee is \$_____ (cash), due when the Female Dog is picked up by her Owner if breeding did take place. If other payment arrangements are made it will be listed in the additional notes below.
4. If the Female Dog is uncooperative and does not want to breed with the Stud Dog, then there is a fee for the time spent on the breeding attempt of \$250.00 (cash) due when Owner picks up Female Dog.
5. There will be a minimum of two (2) breeding's to take place forty-eight (48) hours apart.
6. If the Female Dog fails to conceive a return service is available at no additional charge other than the amount agreed to above. The Stud fee is in no way refundable.



7. The Owner of the Female Dog also agrees that NO puppies resulting from this breeding will be sold to pet stores, nor surrendered to any animal shelters, humane societies, Dog pounds, nor rescues. We can assist in placing puppies if needed.

8. The Owner of the Female Dog warrants that this Female Dog has not been exposed to any Stud Dog prior to her arrival.

9. The Stud Dog Owner will ensure the Female Dog will be protected from any exposure to another Stud Dog while in their custody.

10. The Female Dog Owner also warrants that after breeding she will not be exposed to any other Stud Dog during the remainder of her season.

11. Any litter whelped by the Female Dog between the thirtieth (30th) day and the ninetieth (90th) day after the final breeding attempt will be regarded as belonging to the Stud Dog listed above.

Additional Notes/Instructions: _____

Both parties recognize Seminole County, Florida as the jurisdiction in which this contract - agreement was created, and as such, should any disputes arise as a result of this contract - agreement, which is unable to be resolved amicably, agree that any court proceedings will take place in Seminole County, Florida. The Owner of the Female Dog is responsible for any and all court cost assessed in the resolution of any disputes, and further acknowledges that the Owner of the Female Dog will pay for any claims for lost wages on the part of the Stud Dog Owner as a result of court proceeding.
